Zelis Table Added to Advanced Search and Criteria

[F23454] The 'CostContainZelisClaimReprice' table has been added to the 'Set Criteria' windows within 'Workflow Services' and 'Suspense Criteria'. It has also been added to 'Advanced Search' within 'Claims in Batch', 'Processed Claims', and 'Claim and Claim Batch'. This will allow Users to setup criteria that utilize various Zelis fields.

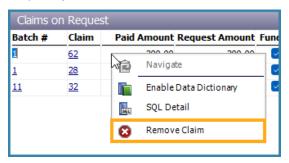
Claim Funding Search Fields

[F22551] Three new text fields have been added to the 'Claim Funding Search' screen: 'Payor Name', 'Account Name', and 'Account Number' as search criteria. The existing 'Payor ID' field has been changed from a drop-down field to a combination text/drop-down field. It will still function as it did previously, but Users may now also enter text and search for a specific Payor ID. Partial Payor IDs will not return results – they must be the full ID.

Claim Funding Remove Claim

[F23294] A new 'Remove Claim' menu item has been added to 'Claim Services' > 'Funding' > 'Requests'. This option will allow Users to select any claim and remove it from a funding request. When selecting this option, the User will be prompted to confirm the claim removal. Removing a claim from a funding request will set its status to 'Ready for Funding' and will recalculate the overall request amount. When this functionality is used, the 'Request' screen will close in order to reload the request information upon reopening.

Auth Review Added to Advanced Search

Exceptions for re-enrollment are the 'Account', 'Case Head', 'Class', 'Student Information', 'Eligibility Status', 'Rate Split', and 'Custom Ex Code' tables which will be updated to empty 'NULL' dates.

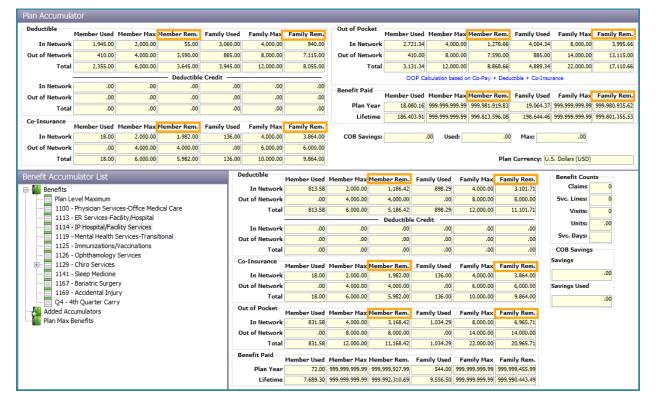

Prior Auth Exempt Providers

[F22688] 'Auth Exempt Procedures' ('Provider Services' > 'Providers' > search for a Provider > Select 'Details' from the header menu) will now be verified against both 'Procedure Codes' on a claim's detail line. In addition, adjudication will check the 'Referring' and 'Attending' Providers if listed on the claim to see if they are exempt from authorizations via this functionality.
